RAJ TV and the Operator are hereina WHERE AS: RAJ TELEVISION TO WORK LIMITED distributes the Channels, inter alia, to the Cable Operators authorized to retransmit signals of satellite New Sion channels through its Digital Addressable System in the DAS Areas. A Cable Operator authorized to retransmit signals of satellite television channels through its vor is desirous to subscribe the Subscribed Channels for further retransmission through its Digital Addressable System subscribers in the Area and RAJ TV is willing to provide signals of the Subscribed Channels to the Operator for retransmission through its Digital Addressable System to the Subscribers in the Area, subject to the terms and conditions NOW THEREFORE, in consideration of the foregoing and the mutual covenants contained herein, constituting good and valuable

1. DEFINITION:

In this Agreement, unless the context otherwise requires, the defined terms below shall have such respective meaning as have been assigned to them hereunder. Additionally, there are other defined terms in the body of the Agreement which shall have such respective meaning as have been assigned to them in the body of the Agreement.

consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows: -

(i) "Digital Addressable System" means an electronic device (which includes hardware and its associated software) or more than one electronic device put in an integrated system through which signals of the Cable Television Network can be sent in an encrypted form, which can be decoded by the device or devices, having an activated Conditional Access System, at the premises of the Subscriber within limits of the authorization made, through the Conditional Access System, and the Subscriber Management System, on the explicit choice and request of such Subscriber, by the Cable Operator to

- (ii) "Applicable Laws" means laws, regulations, directions, notifications, rules or orders, including amendments thereto, enacted or issued by any constitutional, legislative, judicial, quasi-judicial or administrative authority including the TRAI and the MIB.
- (iii) "Area" means Chennai Metropolitan Area which forms part of the DAS Areas.
- (iv) "Bouquet" or "Bouquets" means package(s) of channels, from amongst the Channels, offered by RAJ TV, as are listed in Annexure A-2 of this Agreement.
- (v) "Broadcaster" means the respective owner of the channels.
- (vi) "Cable Operator" means any person who provides Cable Services through a Cable Television Network or otherwise controls or is responsible for the management and operation of a Cable Television Network and totills the prescribed eligibility criteria and conditions.
- (vii) "Cable Services" means the transmission by cable of programs including retransmission by cable of any satellite television signals.
- (viii) "Cable Television Network" means system consisting of set of closed transmission paths and associated signal generation, control and distribution equipment, designed to provide Cable Service for reception by inverige subscribers.
- (ix) "Channels" means the satellite television channels listed in Annexure A-1 of this Agreement
- (x) "Commercial Subscribers" means (i) hotels with ratings of three star and above (in heritage hotels (as specified in the guidelines for classification of hotels issued by Department of Tourism, which ment of India), (iii) any other hotel, motel, inn and other commercial establishments providing boarding and lodging having fifty or more rooms; and (iv) in respect of programs of a broadcaster telecast on the occasion of special common viewing, any place registered under the Entertainment Tax Law and to which access is allowed on payment basis for a minimum of fifty persons.
- (xi) "Confidential Information" means any confidential information (closed by RAJ TV to the Operator while the Operator is participating in the affairs/business of RAJ TV and account other confidential and proprietary information, including the terms and conditions of this Agreement discussed PRAJ TV during the Term.
- (xii) "DAS Areas" means the areas within the Territory when in terms of notifications issued by the Central Government under sub-section (1) of section 4(A) of the Cable Television Networks (Regulation) Act, 1995 (7 of 1995), as amended from time to time, it is obligatory for every cable operator to transmit or re-transmit programs of any channel in an encrypted form through a Digital Addressable System.
- (xiii) "Effective Date" means the Date an eplementation (ACTIVATION) of DAS.
- (xiv) "Equipment" means equipment comprising of digital satellite receivers/professional integrated receiver decoder (PIRDs) with SDI output seems with associated viewing cards and remotes (where applicable) for each of the Subscribed Channels set of which are set forth in *Annexure B* hereto at the sole cost of the Operator, which enables the Operator decrypted signals of the Subscriber Channels.
- (xv) "Intellectual tracerty" means all right, title and interest in the programming and all copyright, creative, artistic and literary contents. Indemarks, trade names, services marks, logs, materials, formats and concepts relating to the Channels be bribed. Channels, or any mark of the right holders of any programming exhibited on the Channels.
- (xvi) "Neans the Ministryof Information & Broadcasting Govt. of India.
 - Wonthly License Fees" means the monthly license fee payable by the Operator to RAJ TV in terms of Clause 5 of this Agreement.
 - "Tier" or "Packages" means various packages offered by the Operator to the Subscribers comprising of channels of various broadcasters.
- (xix) "STB" means the Operator provided and/or the Operator authorized set top box (embedded with the Operator designated vendor designed CAS microchip) installed in the premises of the Subscriber as connected to the television of the Subscriber that allows the Subscriber to receive the Subscribed Channels in unencrypted and descrambled from through its Digital Addressable System.
- "Subscriber" means a person in the Area who receives signals of Subscribed Channels from its Digital Addressable System at a place indicated by such person and uses the same for domestic purposes without further transmitting it to any other person and specifically excludes Commercial Subscriber. For the sake of clarity, one STB in a private residential household or private residential multi-dwelling unit receiving the Subscribed Channels from the Operator either directly or indirectly (through local cable operators) through its Digital Addressable System shall be treated as one Subscriber.

- "Subscribed Channels" means the channels from amongst the Channels and/or Bouquets subscribed/carried by the Operator, as are specifically identified by the Operator by assigning tick marks (*) against such channels from amongst the Channels and/or Bouquets listed in Annexure A-1 and Annexure A-2 to this Agreement.
- "Subscriber Management System" or "SMS" means a system or device which stores the Subscriber records and details with respect to name, address and other information regarding the hardware being utilized by the Subscriber, channels or bouquets of channels subscribed to by the Subscriber, price of such channels or bouquets of channels as defined in the system, the activation or deactivation dates and time for any channel or bouquet of channels, a log of all actions performed on a Subscriber's record, invoices raised on each Subscriber and the amounts paid and discounts allowed to the Subscriber for each billing period.
- (xxiii) "Subscriber Reports" means the monthly Subscriber reports to be provided by the Operator to RAJ TV in terms of Clause 10 of this Agreement.
- (xxiv) "RAJ TV Marks" shall mean all Intellectual Property owned or used by RAJ TV or its affiliates or the Broadcasters from time to time in connection with the Channel/Subscribed Channels, including, without limitation, the trade name trademarks specified by RAJ TV itself, or on behalf of its subsidiaries or the Broadcasters or otherwise, notines in writing by RAJ TV from time to time.
- (xxv) "TDSAT" means Telecom Dispute Settlement and Appellate Tribunal, New Delhi.
- (xxvi) "Technical Specifications" means the technical specifications set forth in Schedule 1 to the Agreement and to which, the STBs, CAS and SMS must comply with.
- (xxvii) "Term" means the period of one (1) year commencing from the Effective Date.
- (xxviii) "TRAI" means the Telecom Regulatory Authority of India.

2. INTERPRETATION:

In the interpretation of the Agreement, unless the context requires otherwise:

- (i) The headings herein are used for convenience only and shall not affect the construction of this Agreement.
- (ii) The references to Annexure and Schedule are references respectively to the annexure to this Agreement.
- (iii) The reference to the singular includes reference to plural and vice
- (iv) The reference to any gender includes a reference to all other senders.
- (v) The term "including" shall mean "including without limb

3. NON-EXCLUSIVE RIGHT:

On the basis of the representations, warranties and indertakings given by the Operator, and subject to the Operator paying the Monthly License Fees RAJ TV hereby grants not exclusive right to the Operator to receive the signals of the Subscribed Channels through the Equipment directly from designated satellites and retransmit the signals of such Subscribed Channels through its Digital Addressable System to the Subscribers (either directly or through the local cable operators) in a securely encrypted manner during the Term (both to be tion, at the Operator's sole cost and expense), subject to the Operator complying with all the terms and conditions as set the Operator's sole cost and expense), subject to the Operator complying with all the terms and conditions as set the Operator hereby specifically understands and acknowledges that the Operator shall not have the built to upgrade the standard definition feed of the Subscribed Channels/Bouquets to high definition feed (by using any technology now available or which may become available in future) at the time of retransmitting the Subscribed Channels/Bouquets through its Digital Addressable Systems. The Operator further understands and agrees that mere possession of the Equipment and/or access to the signals of the Channels/Subscribed Channels does not entitle the Operator to receive and/or retransmit the signals of the Channels/Subscribed Channels and/or use the Equipment in any other mannels whatsoever. All distribution rights not specifically and expressly granted to the Operator under this Agreement, insulation, into the limitation, PPV, NVOD, SVOD, VOD, personal computer, mobile telephony, or any technology now available in future are reserved by RAJ TV.

4. OBLIGATION OF THE OPERATOR:

The operator shall, at its own costs and expenses, receive the Subscribed Channels from designated satellites and retransmit the Subscribed Channels to the Subscribers through its Digital Addressable System, either directly or through local cable operators.

The Operator shall raise monthly invoices on the Subscribers towards subscription of the channels (from amongst Subscribed Channels) and the Operator shall collect such invoiced monthly fees from the Subscribers.

- (iii) Irrespective of the Operator's collection of the invoiced monthly amounts from the Subscribers, the Operator shall pay the Monthly License Fees to RAJ TV, in a timely manner.
- (iv) The Operator shall ensure retransmission of high quality encrypted signal of the Subscribed Channels to the Subscribers.
- (v) The operator shall ensure retransmission of high quality encrypted signal of the subscribed channel (Raj TV, Raj Digital Plus, Raj News, Raj Music, Vissa) to the subscribers in basic package.
- (vi) The Operator shall take all necessary action to prevent unauthorized access of the Subscribed Channels through its Digital Addressable System and shall regularly provide to RAJ TV with updated piracy reports.
- vii) The Operator shall ensure that no Subscribed Channel shall be disadvantaged or otherwise treated less favorably Page 3 of 20

by Operator with respect to competing channels on a genre basis.

5. MONTHLY LICENSE FEES:

- (i) For each month or part thereof during the Term of the Agreement, the Operator shall pay to RAJ TV the Monthly License Fee which shall be the Rate multiplied by the Monthly Average Subscriber Level.
- (ii) The a-la-carte and bouquet "Rate" per Subscriber is set out in AnnexureA-1&A-2 to this Agreement. The rates mentioned in the Annexure to this Agreement, as referred to above, are exclusive of all taxes and levies.
- (iii) The "Monthly Average Subscriber Level" is equal to the sum of the number of subscribers on the first and last day of the month in question divided by two.
- (iv) For the purpose of calculation of the Monthly License Fee payable to RAJ TV, "Subscriber" means, for any calendar month, each Set Top Box, which is availing the Subscribed Channels through the Operator.
- (v) All payments collected by RAJ TV from the Operator shall be on First In First Out (FIFO) basis.

6. CALCULATION OF MONTHLY LICENSE FEE:

- (i) In case the Operator avails one or more Bouquet(s) of RAJ TV:
 - (a) If the Operator is providing the Bouquet(s) as a whole to its Subscribers, the Monthly License Fe Liou such Bouquet(s) shall be equal to the Bouquet rate as set out in the Annexure multiplied by the number of morthly average number of subscribers availing the Bouquet(s).
 - (b) if the Operator does not offer such opted bouquet(s) as a whole to its subscriber but offers only certain channels comprised in such bouquet or packages the channels comprised in such opted bouquet in a manner resulting in different subscriber base for different channels comprised in such opted bouquet, then the payment to RAJ TV for such entire opted bouquet by the Operator, shall be calculated on the basis of subscriber base for the channel which has highest subscriber base amongst the channels.
- (ii) In case the Operator avails one or more or all channels of RAJ TV on a-la-carrente basis:
 - (a) If the Operator is providing the channels on a-la-carte basis to it susceptibers, the Monthly License Fee for such a-la-carte channels shall be equal to the a-la-carte rate as set on in the Annexure multiplied by the number of monthly average number of subscribers availing the channels of ala-carte basis.
 - (b) If the Operator does not offer such opted a-la-cart channel(s) as a-la-carte to its subscriber but offers the a-la-carte channel (s) in packages, then the payment to the package of the a-la-carte channel shall be calculated on the basis of subscriber base of the package in which shall opted a-la-carte channel has been placed.
- (iii) In case the Operator avails one or more channels on a-la-carte rate basis and also opts for different Bouquet(s) not comprising of channels opted on a-la-carte basis of RAJ TV:
 - (a) For bouquet(s), the monthly license (ee sharr be calculated on the basis of Clause 6(i) above.
 - (b) For a-la-carte channels, the month license fee shall be calculated on the basis of Clause 6(ii) above.

Payment of the Monthly License Fee shall be subject to deduction of any withholding tax/ TDS in accordance with the provisions of the Indian Income Tax Act, 1961, as a gended from time to time.

7. PAYMENT TERMS:

- (i) The Monthly Lice see shall be paid monthly in arrears within fifteen (15) days of receipt of invoice raised on the basis of report of the charton by RAJ TV without any deduction except deduction of withholding tax/TDS as provided in this Agreement.
- (ii) Within the may be so fend of each month, the Operator shall provide opening, closing and average number of subscribers for that month, based on which RAJ TV shall raise an invoice on the Operator. In case the Operator fails to send the report with the said period of seven days, RAJ TV shall have the right to raise a provisional invoice and the Operator shall be under obligation to pay the license fee on the basis of such provisional invoice in accordance with the terms of this sause. However the provisional invoice shall be for an amount not more than the monthly license fee payable by the Operator for the immediately preceding month. On receipt of the report from the Operator, the parties would conduct reconciliation between the provisional invoice raised by RAJ TV and the report sent by the Operator.

The Operator shall be required to make payments by the Due Date in accordance with the terms hereof, and any failure to do so on the part of the Operator shall constitute a material breach hereunder. Late payments shall also attract interest calculated from the date payment was due until the date payment is made in full at a pro rata monthly rate of 18% per annum. The imposition and collection of interest on late payments does not constitute a waiver of the Operator's obligation to pay the License Fee by the Due Date, and RAJ TV shall retain all of its other rights and remedies under the Agreement.

- (iv) All License Fee payments here under are exclusive of all applicable indirect taxes including all and any service taxes, VAT, works contract taxes, customs duties, excise duties, entertainment taxes and other such taxes. All such taxes shall be at the Operator's cost and will be charged at the prevailing rates by RAJ TV to the Operator.
- (v) If payment of the License Fee is subject to deduction of any withholding tax/TDS in accordance with the provisions of the

Indian Income Tax Act 1961, as amended, the Operator shall provide tax withholding certificates to RAJ TV within such period as has been specified in the Income Tax Act/ Rules/ Notifications/ Circulars issued there under.

8. DELIVERY AND SECURITY:

- The Subscribed Channels must be delivered by the Operator to subscribers in a securely encrypted manner and without any alteration.
- (ii) The transmission specifications and infrastructure allocated by the Operator in respect of the broadcast signal of the RAJ TV 's Channels by the Operator to its Subscribers shall be no worse than that of the cable signal of any other channel within the same genre on its digital addressable cable TV system platform.

9. ANTI-PIRACY:

- (i) In order to prevent theft, piracy, unauthorized retransmissions, redistribution or exhibition, copying or duplication of any Channel, in whole or in part, (hereinafter collectively referred to as "Piracy"), the Operator shall, prior the commencement of the Term of the agreement and at all times during such Term, employ, maintain, and emprecially effective conditional access delivery and content protection and security systems, and related physical delivery and operational procedures (hereinafter collectively referred to as the "Security Systems") & security specifications as are set for in Schedule 2 and/or may be specified, in a non-discriminatory manner in writing, from time to time, by the Religious contents are set for in Schedule 2 and/or may be specified, in a non-discriminatory manner in writing, from time to time, by the Religious contents are set for in Schedule 2 and/or may be specified, in a non-discriminatory manner in writing, from time to time, by the Religious contents are set for in Schedule 2 and/or may be specified.
- (ii) To ensure the Operator's ongoing compliance with the security requirements set out in the Agreemen, RAJ TV may require technical audits ("Technical Audit(s)") conducted by an independent security technology additor ("Technical Auditor"), approved by RAJ TV in writing no more than twice per year during the Term, at RAJ TV 's cost and expense. If the results of any Technical Audit are not found to be satisfactory by either the Operator or RAJ TV, then RAJ TV shall work with the Operator in resolving this issue in the next fourteen (14) business days. If a solution, so to reached at by then, RAJ TV may, in its sole discretion, suspend the Operator's right to distribute the Chambel or take other actions as provided under the Agreement, until such systems, procedures and security measures have been corrected to RAJ TV's satisfaction the Operator shall bear the cost and expense of any subsequent Technical Audit to verify that the systems, procedures and security measures have been corrected by the Operator to RAJ TV satisfaction.
- (iii) The Operator shall deploy finger printing mechanisms to detect any piracy, violation of copyright and unauthorized viewing of the Channels, distributed / transmitted through its Platform at least every 14 hunters on 24 x7 x 365(6) basis.
- (iv) The Operator shall not authorize, cause or suffer any portion of any of the Channels to be recorded, duplicated, cablecast, exhibited or otherwise used for any purpose other from for distribution by the Operator at the time the Channels are made available. If the Operator becomes aware that any unauthorized third party is recording, duplicating, cable casting, exhibiting or otherwise using any or all of the Channels for any other purpose, the Operator shall within ten minutes of so becoming aware of such recording, duplicating, cable casting, exhibiting or otherwise using any or all of the Channels for any other purpose, notify RAJ TV and the Operator shall also switch off the concerned Set Top Box to prevent such unauthorized use. However, use of a stop Box with Personal Video Recorder/ Digital Video Recorder facility which has been supplied by the Operator shall have be treated as unauthorized use, as long as such Set Top Box is used in accordance with the terms and conditions of the subscription agreement between the Operator and the subscriber.
- (v) If so instructed by Information (as defined below) by RAJ TV, the Operator shall shut off or de-authorize the transmission to any unauthorized subscriber insulging in piracy, within ten minutes from the time it receives during the working hrs such instruction from RLJ TV. Any communication under this clause shall be considered as valid Information only if (i) the information is sent through email in a format as mutually agreed by the parties and (ii) the information is sent by a perso (S) who is designated to send such information. However the "information" may even be provided by RAJ TV representatives through other means of communications such as telephonic message, fax etc. and the said "information" shall late the onlimed by RAJ TV through e mail and the Operator shall be under obligation to act upon such information.
- (vi) RAJ TV plans to a combat piracy of the Channels in the Territory and the Operator undertakes to work closely and provide all such as istance to RAJ TV as may be reasonably required by RAJ TV in that regard. The Operator shall, at its own experience and all necessary steps to comply with obligations set forth in Schedule 2.

10. SUBSCRIBER REPORTS:

- (i) The Operator will maintain at its own expense a subscriber management system ("SMS") which should be fully integrated with the CAS (Conditional Access System). The Operator shall provide to RAJ TV complete and accurate opening and closing subscriber monthly reports for the Subscribed Channels and the tier and/or package containing the Subscribed Channels within seven (7) days from the end of each month in the format provided by RAJ TV. If any subscriber has opted for more than one connection from the Operator, all such additional connections must feature in the Subscriber Report.
 - Such reports shall specify all information required to calculate the Monthly Average Subscriber Level (including but not limited to the number of Subscribers for each RAJ TV Channel and each package in which a RAJ TV Channel is included) and the License Fees payable to RAJ TV and shall be signed and attested by an officer of the Operator of a rank not less than Head of Department/Chief Financial Officer who shall certify that all information in the Report is true and correct.
- (iii) The Operator shall also include in its Subscriber Report, comprehensive details of all incidents of piracy and signal theft involving in its network, the names of perpetrators involved in such incidents, and any actions, including but not limited to the filling of police reports and lawsuits, taken against such perpetrators since the prior Subscriber Report. The obligation of Operator to provide to RAJ TV the Subscriber Reports shall survive termination of the Agreement until RAJ TV receives the Subscriber Reports for each relevant month for which any Monthly License Fee is payable.
- (iv) The Operator shall maintain throughout the Term and for twelve (12) months thereafter (or such longer period as required by

law) sufficient records to enable RAJ TV to verify and ascertain (i) veracity of the Subscriber Reports supplied by Operator pursuant to this Clause, (ii) the payments due to RAJ TV hereunder, and (iii) Operator's compliance with its anti-piracy obligations as set out in this Agreement.

11. AUDIT:

- (i) RAJ TV's representatives shall have the right, not more than twice in a calendar year, to review and / or audit the subscriber management system, conditional access system, other related systems and records of Subscriber Management System of the Operator relating to the Channel(s) provided by the broadcaster for the purpose of verifying the amounts properly payable to RAJ TV under the Agreement, the information contained in Subscriber Reports and full compliance with the terms and conditions of the Agreement. If such review and or audit reveals that additional fees are payable to RAJ TV, the Operator shall immediately pay such fees.
- (ii) Late Payment Interest Rate. If any fees due for any period exceed the fees reported by the Operator to be due for such period by two (2) percent or more, the Operator shall pay all of RAJ TV's costs incurred in connection with scheme and / or audit, and take any necessary actions to avoid such errors in the future.
- (iii) The Operator shall remain the sole owner and holder of all customer databases compiled by the Operator Inder the Agreement.
- (iv) The Operator will maintain at its own expense a subscriber management system ("SMS") capable of, a la minimum:
 - maintaining a computerized customer database capable of recording adequate details of each subscriber, including name, address, chosen method of payment and billing;
 - administering subscriptions of Subscribers by producing and distributing contracts or lev Subscribers and setting
 up and maintaining an infrastructure whereby Subscriber contracts are collected and corded in the SMS database
 for ongoing administration;
 - (c) handling all ongoing administrative functions in relation to Subscribers including, without limitation, billing and collection of subscription payments, credit control, sales enquiries and handling of complaints;
- (v) administering payments of any commission fees from time to time payable to the Operator's authorized agents for the sale to Subscribers of programming packages;
- (vi) obtaining and distributing receivers and smartcards, if applicable, to abscribers, and issue replacement smartcards from time to time in its discretion; and
- (vii) Enable new Subscribers via the SMS over-the-air addressing system and disable defaulting Subscribers from time to time in its discretion.

12. TERM:

- (i) As mutually agreed between RAJ TV and the Operator subject to a minimum of One (1) Year from the date of signing of the Agreement unless terminated earlier in accordance with the Agreement.
- (ii) The Term of the Agreement may be extended on terms and conditions to be mutually agreed and recorded in writing between the parties.

13. TERMINATION:

- (i) Either Party has a right to the other in the event of:
 - (a) material breach of this Agreement by the other Party which has not been cured within thirty (30) days of being required in writing to do
 - (b) the bankruptcy, incovency or appointment of receiver over the assets of the other Party;
 - (c) The digital special cable TV system license or any other material license necessary for the Operator to operate its digital addressable cable TV system service being revoked at any time other than due to the fault of the Operator. RAJ TV shall have the right to terminate this Agreement by a written notice to the Operator if (i) the Operator breaches any of the Anti-Piracy Requirements and fails to cure such breach within ten (10) days of being required in writing to do so; or (ii) RAJ TV discontinues the Subscribed Channels with respect to all distributors and provides the Operator with at least Twenty One (21) days prior written notice.

Operator shall have the right to terminate this Agreement on written notice to RAJ TV if the Operator discontinues as digital addressable cable TV system business and provides at least Twenty One (21) days prior written notice.

RAJ TV shall have the right to terminate this Agreement, or part thereof, by a written notice to the Operator if (a) the Operator breaches any of the Anti-Piracy obligations and fails to cure such breach within ten (10) days of being required in writing to do so; or (b) RAJ TV ceases to distribute any of the Subscribed Channels and provides ninety (90) days' prior written notice to the Operator in that regard.

- (iv) RAJ TV shall have the right to forthwith terminate this Agreement and disconnect/deactivate signals of the Subscribed Channels to the Operator and/or take any other action as may be appropriate, upon occurrence of any of the following:
 - (a) In case of dissolution of the partnership or winding up proceedings against the Operator;
 - (b) In the event of assignment of the Agreement by the Operator without prior written approval of RAJ TV
 - (c) If the Operator voluntarily or by operation of law loses control of the means to distribute the Subscribed

and/or administrative and/or funding purposes, etc.);

- In the event RAJ TV / Broadcasters is/are subjected to legal, governmental or other adverse action under applicable treaties, tariffs or Applicable Laws that restrict the right of RAJ TV / Broadcasters to provide the Subscribed Channels or any part thereof to the Operator or limit the Operator's right or authorization to distribute the Subscribed Channels or in the event of any court order which cannot be reviewed or appealed against, which prevents/restricts RAJ TV / Broadcasters to provide the Subscribed Channels to the Operator under the terms of this Agreement;
- If the Equipment are removed from the Installation Address without prior written consent of RAJ TV or is being used or intended to be used, at a place other than the Installation Address;
- If the Operator's representations, warranties contained in this Agreement are found to be untrue; and
- If the Operator does not comply with any rules, regulations, orders of TRAI or any other government or statutory body/court or tribunal.
- The Parties agree that if any of the agreements between RAJ TV and the Broadcasters relating to RAJ TV distribute any of the Subscribed Channels in the Territory is terminated, then the part of the Agreem to the said Subscribed Channel shall stand terminated. In such an event, fresh Annexure shall between the Parties at mutually agreed terms, subject to applicable law.
- RAJ TV's rights to terminate the Agreement shall be without prejudice to RAJ TV's legal and ahts to any claims under the Agreement, injunctive relief(s), damages, and other remedies available under Appliq
- (vii) The Operator shall have the right to terminate this Agreement on written notice to RAJ TV tor discontinues its digital addressable cable TV system business and provides, if possible, Twenty One (21) written notice.

14. CONSEQUENCES OF EXPIRY/TERMINATION:

- (i) Upon expiry/termination of the Agreement:
 - s, and any agreement between the Parties RAJ TV shall disconnect/deactivate signals of the Subscribed Channels, are any agreement between the Parties for carriage/placement of the Subscribed Channels on the Cable Clausion Network of the Operator ("Allied Agreements") shall automatically terminate Agreements") shall automatically terminate.

The Operator shall immediately return the Equipment of the Susseribed Channels to RAJ TV in good working condition failing which the Operator shall be liable to compensation leadings, equivalent to the Monthly License Fees last paid by the Operator, for each month of delay, on a pro-rata basis.

 Each Party shall return to the other Party all documents. Confidential Information, and other material belonging to the
 - other Party then in its possession; and
 - The Operator shall within seven (7) days of the xpiry/termination pay to RAJ TV all outstanding payments and/or The Operator shall within seven (7) days of the Spiry/termination pay to RAJ TV all outstanding payments and/or other sums (including but not limited to cost/charges/fees/damages/claims for rendition of accounts, if any accrued hereunder or prior to the expiration/termination of this Agreement) that may be payable to RAJ TV under the Agreement as on the date of termination bailing which, such outstanding amounts shall be payable together with interest at the rate of 18% (eighteen per cent) per annum computed form the period of such outstanding becoming due and payable until the date of tayment of such outstaying, along with applicable interest, in full. Those provisions of this Agreement are explicitly, or by their nature, are intended to survive termination or expiry of this Agreement shall survive termination or expiry of this Agreement.

15. EQUIPMENT:

- RAJ TV shall supply cause to be supplied the Equipment to the Operator, directly or through suppliers whin seven (7) days after execution of this Agreement. The Equipment shall at all times nominated by RAJ nd exclusive property of respective Broadcasters. remain the sole

If the Equipment is

to take back possession of the Equipment from the Operator, the Operator shall ensure that he personnel/representative of RAJ TV is allowed free and unobstructed access to the premises of the Operator where the Equipment are installed, and the Operator shall not interfere with such procedure.

ADDITIONAL CHARGES FOR THE EQUIPMENT:

- At the time of supplying the Equipment to the Operator, RAJTV may, at its discretion, require the Operator to make the following payments against delivery of the Equipment:
 - Processing Fee: RAJ TV may require the Operator to pay one-time non-refundable processing fee towards the Equipment for each Subscribed Channel as per RAJ TV policy.
 - Courier/Taxes: The Operator shall pay the courier charges, octroi, taxes and other applicable levies and transportation charges for the Equipment.
 - Refundable Security Deposit: RAJ TV may require the Operator to pay an amount of Rs. 2,500/-, or such amount

as may be determined by RAJ TV from time to time, for each digital satellite receivers/integrated receiver decoder provided by RAJ TV to the Operator under this Agreement. Such refundable security deposit amount shall be refunded by RAJ TV to the Operator upon expiry or earlier termination of the Agreement, subject to the Operator returning the digital satellite receivers/integrated receiver decoder in perfect working condition (reasonable wear and tear acceptable) and also subject to RAJ TV setting off the refundable security deposit amount, or part thereof, with any amount receivable by RAJ TV from the Operator on such date of expiry or termination of the Agreement.

(ii) The abovementioned charges shall be levied on a one time basis during the Term for each of the Subscribed Channels or for any new channel introduced by RAJ TV and subscribed for by the Operator. It is expressly agreed between the Parties that if within one (1) month of the request made, the Operator does not intimate RAJ TV of the receipt or nonreceipt of the Equipment then it will be deemed that the Operator has received the Equipment.

17. REVISION OF RATES/MONTHLY LICENSE FEES:

- (i) The Monthly License Fees payable by the Operator to RAJ TV shall automatically be revised if during the Term a revision of the a-la-carte rates and/or bouquet rates mentioned in *Annexure A-1* and *Annexure A-2*, respectively, of the Agreement ("Tariffs"), of any Subscribed Channels is brought about pursuant to any new regulations/orders stip that TRAI/MIB or any other quasi-judicial or judicial authority and such revised Tariffs shall apply from the date substrevision is notified by such authority; and/or
- (ii) RAJ TV reserves the right to revise the Monthly License Fees, in accordance with the TRALLegiations during the Term RAJ TV revises the Tariffs of the HD Channels.

18. REPLACEMENT/CONVERSION OF CHANNEL:

- (i) RAJ TV reserves the right at any time during the Term to remove and/or delete at y evension channel from the Subscribed Channels ("Removed Channel") and the applicability of this Agreement with reposit to the Removed Channel shall stand terminated. RAJ TV shall have the right to replace any Removed Channel with a replacement channel or to add any channel to the list of Channels and to grant the distribution rights to the Operator in espect of the replacement or new channel. If any channel is removed, replaced or added to the list of Channels, he Wonthly License Fee payable shall be proportionately adjusted. For avoidance of doubt it is hereby clarified that the TV shall use its best commercial endeavors to provide reasonable notice to the Operator with respect to removal or replacement of the Subscribed Channels, provided however that failure to provide any such notice to the Operator hall not be deemed a breach of RAJ TV so obligations hereunder. Additionally, the Operator hereby undertages of to involve RAJ TV and indemnify RAJ TV from any claim/damage/legal proceedings that may be brought against the Operator by any of the Subscriber on account of such Removed Channels (with or without prior notification) and/or increase, if any, in the subscription rates that the Operator may choose to levy on the Subscriber.
- (ii) It is hereby clarified for the avoidance of doubt that among the phannels/Subscribed Channels, if any free-to-air channel is converted as a pay channel or if any pay channel is converted as a pay channel or if any pay channel is converted as a payle shall be proportionately adjusted.

19. REPRESENTATIONS AND WARRANTIES OF RAJ TV:

- (i) RAJ TV represents to the Operator that has the requisite powers and authority to enter into the Agreement and to fully perform its obligations hereunder.
- (ii) RAJ TV makes no representation and/or warranties relating to the continuity, reception and quality and nature of the contents on the Subscribed Channels and RAJ TV shall not be liable for any disruption, discontinuance or interruption in the delivery of the Subscribes Channels to the Operator.
- (iii) RAJ TV shall not, under any occurrences, be liable for the performance of the Equipment for the Subscribed Channels.

20. REPRESENTATIONS, WARRANTIES & UNDERTAKINGS OF THE OPERATOR

- (i) The Operator represents, warranties and undertakes the following to RAJ TV:
 - (a) The perturn has requisite power and authority to enter into the Agreement and to fully perform its obtained hereunder.
 - (b) By executing this Agreement, the Operator is not in breach of any of the provisions contained in any other agreement executed by the Operator with any third party.
 - The Operator has a valid and subsisting license from the applicable statutory authority which permits operation of its Digital Addressable System and the Operator undertakes to keep such license valid and subsisting during the Term and provide a copy of the same to RAJ TV as and when called upon to do so by RAJ TV.
 - (d) The Operator shall abide, implement and ensure compliance to the TRAI Regulations relating to Digital Addressable Cable Systems, in particular the Telecommunication (Broadcasting and Cable Services) Interconnection (Digital Addressable Cable Television Systems) Regulations, 2012, Standards of Quality of Service (Digital Addressable Cable TV Systems) Regulations, 2012 and the Consumers Complaint Redressal (Digital Addressable Cable TV Systems) Regulations, 2012 (as amended from time to time).
 - (e) The Operator undertakes that the Subscribed Channels shall not be disadvantaged or otherwise treated less favorably by the Operator in the packages offered to the Subscriber.
 - (f) The Operator has the capacity to carry the minimum requisite number of channels on its Digital Addressable System, in terms of Applicable Laws.
 - (g) The Operator undertakes to obtain requisite licenses from music societies and/or concerned authorities in

India, if required, and shall be liable to pay any license fee and royalty in relation to such licenses.

- (h) All the Execution Requirements, as listed in Annexure C of this Agreement, provided by the Operator to RAJ TV are correct.
- (i) The STBs, CAS and SMS shall comply with the Technical Specifications and the Operator agrees that the STBs, and their installed CAS microchip, used by the Subscribers shall prohibit use of digital outputs.
- (j) The Operator shall provide the applicable Subscriber Reports and pay the applicable Monthly License Fees, together with applicable taxes, in a timely manner, failing which; the Operator shall be liable to pay applicable interest along with the due payment.
- (k) The Operator shall not retransmit the Subscribed Channels via any medium other than its Digital Addressable System.
- (I) The Operator shall not distribute the Subscribed Channels to any Commercial Subscribers for which one or

more separate agreement(s) shall be executed between the Parties at rates applicable for Commercial Subscribers

- (m) The Operator shall maintain for the Subscribed Channels first-class signal transmission quality in accordance with the highest international industry standards, subject to RAJ TV delivering the signals of Subscribed Channels to the Operator of a quality sufficient to permit the Operator to reasonably comply with such standards. The Operator shall maintain a service availability (a service free from viewer discernible problems including, without limitation, video with no audio, audio with no video or significant signal distortion) that meets or exceeds 99.95% reliability per month (which represents service outages incurred by Subscribers not exceeding approximatily 23 minutes per month) without any interruption or deviation from the daily transmission schedule, and shall immediately notify RAJ TV of any degradation to any of the Subscribed Channels' signals.
- (n) The Operator undertakes to retransmit the signals of the Subscribed Channels in its entirety without (i) any cutting, editing, dubbing, scrolling or ticker tape, voice-over, sub titles, substituting or any other modification, alteration, addition, deletion or variation; and, (ii) replacing, modifying, deleting, imposing or superimposing of advertisements or otherwise tampering with the content of the Subscribed Channels.
- (o) The Operator undertakes not to, either itself or through others, contrape or otherwise reproduce any part of the Subscribed Channels. The Operator further undertakes that it shall be copy or tape programs for resale or deal in any copied programs and shall immediately notify RAJ TV of any chauthorized copying, taping or use of any part of the Subscribed Channels and shall fully cooper ate with all requests by RAJ TV to take such steps as are reasonable and appropriate to cause such activities to ceive it is understood that this shall not apply to the Subscribers using STBs with PVR/DVR facilities. However, the Operator undertakes & ensures that content stored in the DVR and/or external storage device should always to entrypted as a 'Copy Protect' feature.
- (p) The Operator shall not push content onto the STS where shall not be automatic advertisement skipping function and/or the Operator shall not create a virtual wash n-demand or other on demand service in respect of the Subscribed Channels.
- (q) The Operator undertakes not to predice charge, encumber or in any way part with the possession of the Equipment without prior written permission of RAJ TV. Further, the Operator undertakes not to remove or shift or allow removing or shifting, the Equipment rom the Installation Address detailed in the first page of this Agreement or allows anybody else to do the same althout prior written permission of RAJ TV and shall indemnify RAJ TV against any damage, destruction, theft or lost on the Equipment.
- (r) The Operator undertaker to modify, misuse or tamper with the Equipment including the seal (paper seal to prevent opening of the Equipment or any signals emanating there from, in a manner that prevents the identification of the Equipment number or interferes with the signals emanating there from.
- (s) The Operator dertakes to keep the Equipment in good and serviceable order and condition to the satisfaction of RAJ TV and bear all expenses for general repairs and maintenance of the same and it shall immediate portry RAJ TV in the event of any mechanical/technical fault in the Equipment.
- (t) The Speciator undertakes to pay all duties, taxes, fees and other outgoings payable in respect of the Equipment as and writer the same becomes due and payable and shall indemnify RAJ TV against any default or non-payments in this pegard

✔Upon expiry/termination of the Agreement, the Operator undertakes to return to RAJ TV the Equipment in good working condition and pay to RAJ TV all outstanding payments that may be payable to RAJ TV under the Agreement on the date of termination.

- (v) Upon change in the designated satellite of the Subscribed Channels, the Operator undertakes to make all necessary arrangements to ensure continued access to the Subscribed Channels at its own expense.
- (w) The Operator undertakes to keep accurate and complete records and accounts of billings of the Subscribers and make such records available to RAJ TV and/or its representatives for inspection/audit upon reasonable notice.
- (x) Whenever any of the Channels are launched in high definition format, the Operator shall arrange for distribution of the high definition format signals of the applicable channels through its Digital Addressable System, however, subject to separate commercial arrangement between the Parties.
- (y) The Operator undertakes to comply with the Applicable Laws.

21. ADVERTISING AND PROMOTIONS:

- (i) RAJ TV grants to the Operator the non-exclusive right during the Term to use the RAJ TV Marks solely in connection with the marketing and promotion of the Subscribed Channels and in a manner that has been pre-approved by RAJ TV.
- (ii) The Operator undertakes to give:
 - (a) An equivalent amount of marketing support for the Channels as it provides to other channels of the same genre;
 - (b) similar treatment to all Channels in all advertising material whereby Channel logos and/or names appear with the logos and names of other channels in terms of size and prominence and page taking into consideration context; and
 - (c) Equal opportunity to the Channels for participation in events and promotions that the Operator undertakes subject to commercial agreement for each event.

22. INTELLECTUAL PROPERTY RIGHTS:

- (i) It is expressly agreed and understood that the Operator shall not acquire any ownership or other rights with expect to the Subscribed Channels, other than those expressly provided in this Agreement.
- Broadcasters of each Subscribed Channel or its respective affiliated companies or licensor. The Operator shall not acquire any proprietary or other rights in the Intellectual Property to which RAJ TV assert proprietary or other rights, which RAJ TV may notify the Operator from time to time in writing, and agrees not to use the Intellectual Property or trade name. The Operator may use the Intellectual Property solely for the purpose of adventising and promoting the Subscribed Channels only with the prior written consent of RAJ TV. Marketing materials generated by the Operator may refer to the Intellectual Property only if it is clear that such Intellectual Property Refuses the trademarks or service marks for the Subscribed Channels, which are distributed by the Operator. Such marketing materials shall require the prior written approval of RAJ TV. The Operator shall not acquire any proprietary or other rights over the RAJ TV Marks, and agrees not to use RAJ TV Marks without prior written consent of RAJ TV. Unless notified to the contrary by RAJ TV, in all trade references, advertising, promotion and for all other purposes, the Subscribed Channels shall be referred to exclusively as designated herein or as otherwise designated by RAJ TV. To the exist any of such rights are deemed to accrue to the Operator, the Operator agrees that such rights are the exclusive property of RAJ TV as applicable. RAJ TV reserves the right to inspect any such material at any time without prior notice. The Operator shall not use any Intellectual Property as part of a corporate name or of a trade name, register or use any part of mark which is the same as, or which contains or which, in the opinion of RAJ TV, resembles any of the Intellectual Property. The Operator shall include appropriate copyright and other legal notices as RAJ TV may femble, and shall promptly call to the attention of RAJ TV the use of any Intellectual Property or any other names or marks that in the opinion of RAJ TV are similar to any Intellectual Property, and sh

23. LIMITATION OF LIABILITY:

- (i) Notwithstanding anything to the contrary in this Agreement, to the maximum extent allowed under the applicable law, except where a Party is independent against third party claims, in no event shall any Party be liable for any incidental or consequential damas. Wether foreseeable or not (including those arising from negligence), occasioned by any failure to perform or the breach of any obligation under this Agreement for any cause whatsoever.
- (ii) Any and all express and implied warranties, including, but not limited to, warranties of merchantability or fitness for any purpose of use, are expressly excluded and disclaimed by the Parties, except as specifically set forth herein.

24. CONFIDENTIALNY:

The Operator shall keep in strict confidence any Confidential Information received by it from RAJ TV and shall not disclose the alice to any person, not being a party to this Agreement. The Operator shall also bind its employees, officers, advisors, associates, contractors, agents and other similar persons, to whom the Confidential Information may be disclosed, to the obligations of such confidentiality. However, any disclosure of Confidential Information by the Operator to any of its employees, officers, advisors, associates, contractors, agents and other similar persons shall be strictly on a need to know basis. Confidential Information shall, at all times, remain the exclusive property of RAJ TV and the Operator shall not acquire any rights in the Confidential Information with an exception to court and govt agenizes

25. FORCE MAJEURE:

Neither Party shall be liable for any delay in performing or for failing to perform any or all of its obligations under this Agreement resulting from force majeure conditions including satellite failure, satellite jamming, occurrence of an event over which the affected Party has no control, etc., which may affect the retransmission of signals of any of the Subscribed Channels to the Operator/Subscribers. In the event of a suspension of any obligation under this clause, which extends beyond a period of one (1) month, the Party not affected, may at its option, elect to cancel those aspects of this Agreement.

26. NO AGENCY:

Neither Party shall be or hold itself as the agent of the other under the Agreement. No Subscribers shall be deemed to have any private of contract or direct contractual or other relationship with RAJ TV by virtue of this Agreement or by RAJ TV's delivery of the Subscribed Channels to the Operator. This Agreement between RAJ TV and the Operator is on principal to principal basis and is terminable in nature.

27. NO WAIVER:

The failure of either Party to resist, in any one or more instance, upon performance of any of the provisions of this Agreement or to enforce any such provisions or the relinquishment of any such rights, shall not make such provisions/rights obsolete and such provisions/rights shall continue and remain in full force and effect. No single or partial exercise by either Party of any right or remedy shall preclude other future exercise thereof or the exercise of any other right or remedy. Waiver by any Party of any breach of any provisions of this Agreement (or the consequences of any such breach as provided for in this Agreement) must be in writing and signed by the Parties hereto and such waiver shall not constitute or be construed as continuing waiver or as a waiver of any other breach of any other provisions of this Agreement.

28. ASSIGNMENT:

- (i) Notwithstanding anything contained in the Agreement, the Operator shall not have the right, without the pror written consent of RAJTV, to assign or transfer the Agreement or any of its rights or obligations hereunder to any third Party. Upon any breach, whether actual, potential or threatened, of this clause, the Operator shall be deemed to be unauthorized to retransmit the signals of the Subscribed Channels, as the case may be, and in material breach of the Subscribed Channels and take any other measures as may be lawfully appropriate.
- (ii) RAJ TV may, at any time, assign the Agreement including, without limitation, its rights and obligations hereunder, either in whole, or in part, to any person or third party and such person or third party shall, to the extent of such assignment, be deemed to have the same rights and obligations as RAJ TV his a vis the Operator. Such assignment by RAJ TV shall be effective on and from the date as communicated in writing by TV to the Operator.

29. INDEMNITY AND THIRD PARTY CLAIMS:

- (i) The Parties shall forever keep and hold the other Party and such Party's subsidiaries, affiliated companies, officers, directors, employees and agents fully indemnified and harmless against all liabilities, claims, costs, damages and expenses (including, without limitation, reasonable attorney's fees) resulting due to any of the defaulting Party's acts, omissions, misstatements, and representations, warranties, undertakings or otherwise (see our hereunder or any of its obligations pursuant to the Agreement.
- (ii) Except as provided under the Agreement, neither that shall have any rights against the other Party for claims by third persons or for non-operation of facilities or non-furnishing of the Subscribed Channels, if such non-operation or non-furnishing is due to failure of equipment, satellite action or natural calamity.
- (iii) RAJ TV makes no representations or warrant as to whether or not the Subscribed Channels or any of its content requires any governmental consent or approval or as to whether or not the Subscribed Channels complies with laws and regulations of any governmental and other authorities for its distribution. The Operator shall be responsible, at its sole cost and expense, for obtaining all necessary approvals, licenses and permissions, as may be imposed or required by the government and other authorities, for the distribution of the Subscribed Channels by the Operator and maintaining those approvals, licenses and permissions inroughout the Term.
- (iv) This clause shall survive tengination of the Agreement.

30. SEVERABILITY:

If any provision of Agreement becomes invalid, illegal or unenforceable, in whole or in part, the validity of the remainder provisions of this Agreement shall not be affected thereby, and the Parties shall agree to a valid substitute provision, which concesponds in its economic effect as closely as legally possible to the invalid or unenforceable provision which it replaces.

31. NOTICES.

All others given hereunder shall be given in writing, by personal delivery, Speed Post or Registered Post A.D., at the correspondence address of the Operator and RAJTV set forth in the Agreement, unless either Party at any time or this designates another address for itself by notifying the other Party thereof by Speed Post or Registered Post A.D. only, in which case all notices to such Party shall thereafter be given at its most recent address. Notice given by Registered Post A.D. shall be deemed delivered on the third day from the date of dispatch of such Registered Post A.D. All notices to RAJTV shall be addressed in the attention of "Head-Distribution", RAJ TELEVISION NETWORK LIMITED., No:32, Poes Road, 2nd Street, Teynampet, Chennai-600 018.

32. GOVERNING LAW, JURISDICTION AND DISPUTE RESOLUTION:

The rights and obligations of the Parties under the Agreement shall be governed by and construed in accordance with the laws of India. The TDSAT, to the exclusion of all other courts, shall have exclusive jurisdiction in respect of any dispute between the Parties arising out of or in connection with or as a result of this Agreement.

33. ENTIRE UNDERSTANDING/ MODIFICATIONS:

The Agreement along with its Schedules and Annexes contains the entire understanding between the Parties with respect to the subject matter covered herein. It supersedes all prior understandings between the Parties with respect to the subject matter hereof. Subject to any new regulations/orders stipulated by the TRAI/MIB or any order of the court/tribunal, any modification, variation, alteration and amendment of the provisions of the Agreement shall be mutually agreed in writing and executed by and on behalf of the Parties. In the event the Parties fail to mutually agree upon such amendment, RAJ TV shall have the right to terminate this Agreement without any further obligation towards the Operator.

THE OPERATOR S ANTI-PIRACY OBLIGATIONS

1. General

1.1 The Operator shall take all necessary actions to prevent any unauthorized access to the Channels/Subscribed Channels through its Digital Addressable System.

2. STBs, VCs, Systems and Procedures

- 2.1 In order to ensure that each STB is capable of being used for Fingerprinting, the Operator shall ensure that the STBs supplied to Subscribers conform to the Bur eau of Indian Standards established under the Bur eau of Indian Standards Act, 1986.
- 2.2 The Operator represents, warrants and undertakes that there are adequate systems, processes and controls in place regarding the distribution of STBs and VCs so as to ensure that they are only sold by the Operator of by its authorized dealers and such sales are only made to bona fide Subscribers and installations are made at an applicable residential address. Adequate systems, processes and controls shall include, without limitation, the operator:
 - 2.2.1 collecting and maintaining complete up to date records of each and every Subscribe's details, and details of the location of every STB and VC including, without limitation, the particulars specified in paragraph 2.4;
 - 2.2.2 requiring all Subscribers to submit a utility bill or bank statement as proof of address in teding any Subscribers who have been previously de-authorized prior to re-authorization, or independently plushedly verify the address by a person other than the dealer/sales unit, prior to activation of any STB and VC:
 - a person other than the dealer/sales unit, prior to activation of any STB and VC:

 2.2.3 investigating any multiple VC issued under one individual name or address, including visiting the premises of such individuals or addresses from time to time;
 - 2.2.4 requiring that for every change of address on the system and therefore reportion of a STB, there is an independent physical verification of the new residential address; and
 - 2.2.5 de-authorizing any STB or VC that is found outside the Area or in the assession of a person who is not a bona fide Subscriber
- 2.3 The Operator represents, warrants and undertakes that all of its TB- and VCs: (i) are sold and installed together as a pack only and installed only at the premises of Subscribers whose address has been verified in accordance with paragraph 2.2.1; and (ii) employ card-pairing technology that ensures to a VC is activated and paired to a particular STB, the Channels/Subscribed Channels cannot be viewed in STB is removed and used with any other STB or used with a set top box of any other operator.
- 2.4 The Operator represents, warrants and undertakes that all installations of STBs and VCs are done directly by the Operator or through its authorized dealers and that the installer for every installation physically checks and ensures before installation and activation of a STB and VC has the address where the installation is being done matches with the address as supplied by the Subscriber at the time of phychase/hire purchase/renting of the STB and which is the same as detailed in the SMS. In accordance with paragraph 2.3.7, the Operator's SMS shall contain all of the following information items for each Subscriber prior to activation (1) and VC for such Subscriber:
 - 2.4.1 Name;
 - 2.4.2 Installation address.
 - 2.4.2 Billing address (if different)
 - 2.4.4 Telephone number on the installation address, where applicable;
 - 2.4.5 Subscriber's subscriber reference or subscription agreement number;
 - 2.4.6 Channels/Bouquets that have been selected;
 - 2.4.7 VC number, and
 - 2.4.8 Unique STB number.
- 2.5 The One agrees and undertakes that it shall not activate, or otherwise reactivate, as the case may be, those was wherein the Channels/Subscribed Channels can be accessed from addresses which are:
 - not bona fide or do not match the addresses as supplied by the relevant Subscribers as detailed in the SMS; or outside the Area; or
 - 2.5.3 that of a cable head end or any other distributor of such Channel.
 - In order to ensure that the VC is only activated for bone fide Subscribers, the Operator further represents, warrants and undertakes that there are adequate controls to ensure (a) a VC is not activated before installation with its paired STB; and (b) that such VC is activated at the address of the Subscriber which matches with the address as supplied by the Subscriber at the time of purchase/hire purchase/renting of the STB and which is the same as detailed in the SMS.
- 2.7 The Operator represents, warrants and undertakes that it's SMS: (a) allows viewing and printing historical data, in terms of total activation, de-activation and re-activation of all Subscribers and all other records required under paragraph 2.4; and (b) enables the location of each and every STB and VC to be recorded.

3. Fingerprinting

3.1 The Operator shall ensure that it has systems, processes and controls in place to run Fingerprinting at regular intervals as per the specifications provided by RAJ TV and as reasonably requested from time to time.

- 3.2 The Operator shall ensure that all STBs should support both visible and covert types fingerprinting and should be compatible for running Fingerprinting whether operated by the Operator or by RAJ TV.
- 3.3 The Operator shall ensure that it shall be able to operate the Fingerprinting across all Subscribers based on preset parameters and such Fingerprinting should, apart from the foregoing, be possible and available on global, group and regional bases at all times. On screen display should support a minimum number of characters that preserve uniqueness to that VC and STB and any amendment of those characters will be on a pre-determined, consistent basis.
- 3.4 The Operator shall ensure that the following processes shall be deployed to keep a check on piracy and misuse of the signals of the Channels:
 - The Channels' Fingerprinting should pass through without masking or tampering with respect to time, location, duration and frequency;
 - Fingerprinting to be provided by the Operator on the Channels, as per the scheme provided by RAJ 7 3.4.2 shall have a right to give the time, location, duration of Fingerprinting at a reasonably short notice minutes prior notice or more).
